FOR ALL EXISTING PLAYERS THE BALANCE OF \$400 DUE AND PAYABLE PRIOR TO OR AT THE FIRST SCHEDULED HOCKEY LEAGUE GAME FOR THE 2025/2026 SEASON. **TOTAL ANNUAL DUES OF \$450.** FAILURE TO NOTIFY THE TREASURER, ONE MONTH PRIOR TO THE COMMENCEMENT OF THE UPCOMING HOCKEY LEAGUE SEASON THE PLAYERS INTENT TO CANCEL HIS MEMBERSHIP, THE PLAYER WILL FORFEIT HIS \$50 TO ADMINISTRATION FEES.
